Kids that are Learning Ready: are developmentally ready to enter school, experience quality early care and education and maintain early gains to succeed academically. In FY17, ReadyKids Learning Ready Programs (Child Care Quality, ReadySteps, Family Coordination, Play Partners and STAR Kids) impacted 6,191 kids, families and child care providers and 92% had quality early learning experiences that prepared them for school and life.

4b (Code: _____) (Expenses \$ 1,153,959 including grants of \$ _____) (Revenue \$ 109,895)

Relationship Ready Kids experience positive, nurturing and healthy family relationships. Kids that are Relationship Ready: relate well to others and are socially/emotionally healthy, experience positive parent/child/family interactions, are free from abuse and neglect and receive support with family crises and related mental health problems. In FY17, ReadyKids Relationship Ready Programs (Healthy Families, REAL Dads, Teen Counseling and Inside Out Counseling) impacted 1,745 kids, families and child care providers and 96% experienced nurturing, healthy and developmentally appropriate family relationships.

It is then presented to the Board of Directors, who approve the final version before submission.

The policy is review with board members during orientation and annually, with each Board member signing a written contract affirming their commitment to the written policy. During Board meetings, and as issues arise, Board members are asked about potential conflicts of interest. Board members are expected to recuse themselves if any conflict arises that might question decision-making.

Form 990, Part VI, Section B, Line 15 - All compensation is reviewed through multiple means. First, the Board's Operations Committee conducts a salary and benefits survey every three years to compare agency salary and benefits with other local non-profits' and government agencies. Second, the Operations Committee recommends, and the board approves all cost of living increases. Finally, the Operations Committee reviews the agency's salary classification levels annually, which sets the compensation range for each level of position in the agency. The Executive Director's compensation is reviewed and determined by the full Board upon hire and with any subsequent salary adjustments.
